TSP/90 Heavy Duty Cleaner Product No. 0261, 0265

Description

TSP/90 is a white crystalline solid cleaner that deep cleans many washable surfaces without excessive scrubbing. It neutralizes & floats away grease, grime, dirt, oil & smoke film.

Key Features

- Readily soluble in water
- Excellent shelf-life when stored as directed
- Contains no Phosphates or abrasives

Uses

Uses include general wall and floor cleaning. Not recommended for varnished wood floors. Windows, mirrors & other glass surfaces should be protected from contact with TSP-90 solution.

Solution Preparation

Following label directions slowly add required amount of crystalline solid to water while stirring. Mix until crystalline solid is in solution.

Directions

1. Wearing appropriate protective gear so as to prevent eye & skin contact (appropriate goggles, gloves, apron), wet sponge or cleaning cloth with solution & clean surface.
2. Wipe surface with clean water. DO NOT ALLOW CLEANING SOLUTION TO DRY ON SURFACE.

Clean Up

If product is allowed to dry on surface, it may leave a film. Film can be removed by scrubbing with a non-abrasive cleanser. Wash skin with warm water/mild soap solution. AVOID SKIN & EYE CONTACT WITH CLEANING SOLUTION.

For Best Results

- Windows, mirrors & other glass surfaces should be protected from contact with TSP-90 solution.
- Avoid eye & skin contact.
- Do not allow cleaner solution to dry on surface.
