**Clean-Up Solvent (Before cured):** Use Red Devil® Gun Cleaner (if done immediately) Cured foam can not be removed with solvents. If foam hardens on skin, use industrial hand cleaner or petroleum jelly, leaving on for 1 hour. Foam can eventually be removed from skin with repeated effort and is not harmful to health.

**Shelf Life:** 15 months (unopened at 77°F (25°C))

**Storage:** Store in cool, dry area. Store in upright position at temperatures above freezing. Avoid temps above 100°F

### APPLICATION PREPARATION:

Shut off all gas pilot lights, electrical igniter's, burners and other sources of ignition and heat before and during use, as this product is **FLAMMABLE** during dispensing. Surface should be clean, dry & free of contaminants for maximum adhesion.

### FOR BEST RESULTS:

- Surface must be clean, dry and free of all outside material for adhesion.
- Shake can vigorously for at least 1 minute before using.
- Dispense product with cannister UPSIDE-DOWN position.
- Apply when temperature is above 41°F and below 86°F. (Extrusion in lower temperatures will be slow and product curing may be effected).

### CLEAN-UP:

Uncured Foam - Clean immediately with Red Devil Gun Foam Cleaner. Cured Foam - cannot be removed with solvents. If foam hardens on skin, apply petroleum jelly, put on plastic gloves, leave on for 1 hours and rub off with clean cloth. Repeat if necessary. Foam that cannot be removed will wear off in time.

### RESTRICTIONS:

- Not recommended for filling enclosed cavities. Do not use between walls or under tub surrounds as expansion may alter dimensions.
- Can be used on virtually all, clean surfaces EXCEPT Teflon, Silicone and Polyethylene.
- Do not expose to rain or excessive moisture for 6 hours.
- Do not apply to surfaces with excessive Moisture content.
- Flammable during dispensing.
