Description

SAV-A-Brush is a white crystalline (solid) brush restorer that restores synthetic bristle brushes containing deposits of dried paint residue. WEAR ADEQUATE PROTECTION SO AS TO PREVENT SKIN & EYE CONTACT.

- Excellent shelf-life when stored as directed

Uses

Restores synthetic bristle brushes containing deposits of dried paint residue.

Solution Preparation

Dissolve SAV-A-Brush into water by adding slowly to water (avoiding splashing) & constant gentle stirring until dissolved.

Directions

- 1. Following label directions, add contents slowly to water.
- Stir gently (avoid splashing) until dissolved.
- Place synthetic bristle brushes only into solution & occasionally "work" bristles in the solution.
- Remove brush & rinse in cool water.
- Repeat as necessary.
