APPLICATION:

Remove old caulking/sealant. Surface must be clean, dry & free from dirt, dust, grease, oil, mildew, wax, loose paint, frost, & other residue or material that may interfere with adhesion. Clip off tip of nozzle/spout @ 45° angle to desired bead size. Load cartridge into caulking gun and apply. Smooth caulk using a Caulk Smoother, Putty Knife or Damp Cloth. Remove excess with a damp cloth before surface skins over. Full clarity reached in 1 to 2 weeks.

FOR BEST RESULTS:

- Apply only with excellent ventilation (See MSDS).
- Store cartridge @ room temperature (72°F to 77°F) prior to use if application temperature is below 40°F.
- Do not store or use around heat, open flame, etc. - Product flammable
- Apply to dry surfaces whenever possible although product will adhere to damp substrates as well.
- Remove temporary sealant after 3 to 6 months.

CLEAN-UP:

Mineral Spirits or Toluene before cure (See solvent label for directions & cautions)

NOTE: Some Orange-Based Cleaners also work. See label directions/cautions.

LIMITATIONS:

- Not for use in areas of complete submersion.
- Not FDA or USDA approved.
- Not recommended for pool or hot tub applications.
- Not recommended for adhering mirrors.
- Do not apply to recently painted surfaces.
